

## (1) What is CAFT/EFT?

CAFT is the system that our bank uses for Electronic Fund Transferring (EFT). It's similar to when you pre-authorize payments for things like insurance, or loans.

## (2) Why use it?

It's an automatic system so, once set-up, you don't have to worry about it. The money will come out of your account on the designated day and that's it.

## (3) Is it better than Canada Helps or Chimp?

Yes! Canada Helps and Chimp are great services that allow you to give on a monthly basis and they also issue tax receipts on our behalf. Because they offer a service, they take a small percentage of your donation as an administrative fee.

If you set-up EFT directly with the Table then we receive your donation less \$0.10 (that's it!)

## (4) When will the money come out of my account?

You can either sign up to have the **money withdrawn on the 1st or the 16th** of every month. However, the service does not work on weekends or holidays so if the 1st or 16th fall on a Saturday, Sunday or holiday then you can expect the money to be withdrawn on the next business day.

## (5) How do I get set-up?

You need to fill out an agreement form and attach a void cheque to it in order that we can get your banking information. You can then return the form and cheque to the church or get in touch with our bookkeeper, **Sophie Wooding**, at [sophie@tablechurch.ca](mailto:sophie@tablechurch.ca)

## (6) I'm not ready to give on a regular basis this month but I want to start giving in the future. Can you help?

Yes! Just write on the agreement form when you want to start regularly giving and we'll set it up accordingly.

## (7) Can I ever make changes to or cancel my giving once I set up EFT?

Yes! It's as simple as contacting Sophie Wooding at [sophie@tablechurch.ca](mailto:sophie@tablechurch.ca) and signing a new agreement form.
